Dear Valued Customers,

AIP Runway data sources are used in the EGPWS Terrain Database to support the TAWS alerting algorithms and other advanced functions (e.g., RAAS). The AIP AIRAC cycle upon which each Terrain Database release cycle is based is identified in the Release Statement. Airport changes, including new airports/runways, modified runway lengths and runway ID changes that are not reflected in the current Terrain Database release cycle may result in nuisance alerts until a subsequent release cycle.

The information below identifies the locations where airport/runway changes have been identified since the release of the most current database, and the possibility of nuisance alerts exists. Honeywell's awareness of these changes is generally through AIP updates, NOTAMs and customer feedback.

Customers are advised to use the most current database available. For locations with the possibility of nuisance alerts due to runway data currency, customers are advised to provide operational guidance to pilots, included use of Terrain Inhibit if warranted.

Honeywell remains committed to maximizing our awareness of airport/runway changes, whether reflected in current AIP data or anticipated in the near future, to the best of our ability, and working quickly to address discrepancies as soon as possible.

AIRAC cycle 2505 was used for TDB version 646, which was released on June 04, 2025. The following runway changes in the AIRAC cycle 2506 have been identified and included in this notification.
